



Did you know?

Not all materials can be recycled since markets for the final product have to exist, and sometimes it is too expensive in either money or in resources to go through the steps to collect, transport, sort, clean and process the items put into a bin. That is why it is important to look at other options first before recycling.

The Four R's of Sustainability

REDUCE consumption by limiting unnecessary purchases. You will save money while making a better choice for the planet.

REUSE goods as much as possible to give them a longer life. Donate items when in good condition but no longer of use to you.

RECYCLE what you can. Know which transfer station accepts recycle items such as electronics, tires, and oil.

RECOVER what you can. Composting at home is a great way to supplement your garden soil.

Change is coming!

Ag Plastic Jug Recycling

Ag plastic jug recycling will no longer be available at the Border Seed Cleaning and Sunshine Seed Cleaning facilities after December 31, 2024. Recycling of these products will be available through the ag retailers instead.

Extended Producer Responsibility (EPR)

Created by the Government of Alberta, this system is intended to encourage businesses to find new ways to recycle materials and reduce waste at the source. This would mean the costs for the recycling system will be accounted for in the cost of a product—not in property taxes.

Implementation of this program in the County of Warner is expected in 2026, at which time new methods to recycle paper, packaging, single-use products, and household hazardous products such as batteries and corrosive liquids may become available.

Types of waste accepted:

- Domestic garbage (not including toxic or hazardous waste, or yard waste such as grass clippings and fallen branches)

Types of waste accepted:

- Domestic garbage (not including toxic or hazardous waste)
- Burnable materials

Chief Mountain Regional Solid Waste Services Commission

The Chief Mountain Regional Solid Waste Services Commission (CMRSWSC) controls the landfill site where local transfer station garbage eventually ends up. The CMRSWSC is directed by the municipal members, including the County of Warner.
